## I. Definitions

- For the purpose of these terms and conditions ("Terms and Conditions"):
- "Program Period" or "Offer Period" shall mean period commencing from November 15, 2018 to December 31, 2018 (both days inclusive).

  Card Holder/s by entering card details for making payments at online merchant payment gateway during

  outlets.
